
Sub:-Clarification regarding qualification pay of officials passed confirmation examination for Direct Recruitment as Junior Accountant.

Sub: Grant of qualification pay to departmental
examination passed LDCs.

Sir/Madam,

Kindly refer to our letter no. 33-1/24/P.A./1/83
to 1072 dated 9/9/83 allowing qualification pay to
employees of the Postal Accounts Deptt. who have passed
departmental confirmatory/departmental examination. As per
the Govt. of India orders on this subject, the qualification
pay is required to be granted from the date of passing the
examination i.e. from the day following the last date of
examination in which the candidate has been
successful. It has come to our notice that the orders
not being correctly followed in the cases of those LDCs
who are awaiting promotion after passing the prescribed
departmental examination. Such of the LDCs who have passed
the departmental examination are also entitled for
qualification pay from the date of passing the exam.
All such cases, where a different method has been followed for
grant of qualification pay, may be reviewed w.e.f. 1/0/84
and regulated accordingly.
