In continuation with this office letter of even number dated 08.07.2009 (Copy enclosed), I am to convey the approval of the Chairman, Navodaya Vidyalaya Samiti for change of permanent site for establishing of second Jawahar Navodaya Vidyalaya at the following place subject to the conditions contained in this letter and also as per Inspection Report submitted by the Site Selection Committee.

2. The Vidyalaya is already functional from its temporary site mentioned above from the Academic Session 2009-10 onwards. The initially offered land at Village Koluha Sonvarsha, P.O. Mohammadganj transferred in favour of Navodaya Vidyalaya Samiti. However, construction of the Vidyalaya could not be started as it was not found sufficient for construction of the Vidyalaya. Construction could not be started at the alternate land offered at Village Teta, P.O. Japla, Hussainabad as it was not transferred in favour of Navodaya Vidyalaya Samiti. Now the State Government has offered the above alternate site for construction of the Vidyalaya at Permanent Site and the same has been transferred in favour of Navodaya Vidyalaya Samiti.

3. For the effective management of the Vidyalaya, it has been decided to designate District Magistrate/Deputy Commissioner/Collector of the concerned district as the Chairman of the Vidyalaya Management Committee. The establishment of the aforesaid Jawahar Navodaya Vidyalaya is subject to the conditions that the permanent site allotted for the construction of JNV complex will have to be made functional from the point of view of its utilization with provision of roads, access to the premises, supply of water, electricity, telephone connection etc. at the cost of the State Govt.

4. The land allotted for construction of Vidyalaya buildings shall be free from all encumbrances and rights and NVS will have no liabilities in this regard in future.



2. The Vidyalaya is expected to start functioning after the Navodaya Vidyalaya Selection Test is held for admission to Class VI, for the Vidyalaya indicated above. The Principal will be posted in due course. For the effective management of the Vidyalaya, it has been decided to designate District Magistrate/Deputy Commissioner/Collector of the concerned district as the Chairman of the Vidyalaya Management Committee whose functions shall be communicated to him separately.

3. You are requested to issue the following instructions to the concerned authorities with regard to the establishment of the aforesaid Jawahar Navodaya Vidyalaya: -

- a) The District Magistrate/Deputy Commissioner/Collector should be asked to make available 12 acres of land, free of cost as promised/assured in the Inspection Report and to transfer the same in favour of Navodaya Vidyalaya Samiti. Wherever the land does not belong to the State Govt., arrangements for procuring the same and transferring it to the Samiti may be made on priority basis by the District Authority. The possession of land shall be taken over by the District Magistrate/ Principal of the Vidyalaya concerned on behalf of the Samiti.
- b) Any building offered at the permanent site will have to be made functional from the point of view of its utilization with provision of roads, access to the premises, supply of water, electricity, telephone connection etc. at the cost of the State Govt., under their regular programmes such as NREP, RLEGP etc.
- c) The permanent/temporary accommodation as promised/assured in the Inspection Report should cater to the minimum needs of approximately 60 boys, 20 girls and 12 teaching and non-teaching staff in the first year. Although the Samiti plans to complete the construction of the permanent building at the land offered, at the earliest, such a construction may take 3 to 4 years and it will, therefore, be essential that the permanent/temporary accommodation should also cater to the needs of the subsequent expansion of the Vidyalaya for 3 to 4 years. This expansion will be about 80 children every year and consequential increase of 4 to 5 staff every year.
- d) Wherever the buildings offered are under the occupation of any other party, they should be got vacated well in advance. Necessary repairs of the buildings should be carried out, immediately. Under no circumstances would another institution be permitted to start within the Jawahar Navodaya Vidyalaya Campus.
- e) The Samiti will not pay any rent for any temporary/permanent building offered for the use of the Vidyalaya.
- f) To permit the District Magistrate/Deputy Commissioner/Collector to act as a Chairman of the Vidyalaya Management Committee and to open a Vidyalaya Account in a Nationalized Bank only for the purpose of operating the funds being released to him by the Hqrs. or the Regional Office of the Samiti. This account shall be transferred to the Principal when he takes over the charge of the Vidyalaya.
- g) All minor repairs like white-washing, water connections, electricity connections for the buildings, being offered, should be immediately attended to by the sponsoring authority. Toilets/Bathrooms, normally one each for every 10 students should also be got constructed before the Vidyalaya functions.

4 If any of the conditions mentioned above and in the Inspection Report are not fulfilled, it will be open for the Samiti to re-consider the proposal and keep in abeyance the actual conduct of the Jawahar Navodaya Vidyalaya Selection Test in District Palamu, Jharkahand.

5 The Jawahar Navodaya Vidyalaya Selection Test for admission to Class VI in the said Vidyalaya will only be held after the land and building at permanent site and temporary site have been handed over to the Principal by the District Authority, as promised/assured in the Inspection Report. In case the land and building at permanent and temporary sites are not handed over to the Principal, the responsibility is fixed with the State Government for providing the land and building for the establishment of the Vidyalayas. Any delay in handing over the building may lead to Jawahar Navodaya Vidyalaya Selection Test being postponed to the next academic year.
