Sl.No.	Particulars	Ceiling of numbers of cases
1	Ceiling on the appearing as Defence Assistants by the Retired Government Servants	Retired Government Servant should not act as a Defence Assistant in more than 7 cases at a time under Rule 10 of GDS (Conduct and Engagement) Rules, 2020. In case a retired Government Servant acts as Defence Assistant under CCS (CCA) Rules, 1965 also, then the limit as prescribed for Defence Assistant under Rule 10 of GDS (Conduct and Engagement) Rules, 2020 shall also include such cases, which fall under CCS (CCA) Rules, 1965.

- The rest of instructions issued vide Department of Posts O.M. of even number 3. dated 16.09.2019 shall remain unchanged. The above instructions will come into Tam Milta effect from the date of issue of this O.M.
