- 3. While examining such cases, Ministry of Finance, Department of Expenditure have taken a serious view in the matter and have once again advised that relaxation on grounds of ignorance/unawareness about the guidelines would not be considered.
- 4. MoF/DoE's guidelines regarding purchase of air ticket from authorized agents etc issued vide their O.M. No. 19024/22/2017-E.IV, dated 19.07.2017 and circulated over Indian Railway vide Board's letter of even number dated 21.09.2017 are therefore re-circulated herewith for strict compliance. These guidelines should also be brought to the notice of all concerned.

Guidelines on Air Travel on Official Tours - Purchase of air tioket from authorized agent,

The undersigned is directed to refer to this Departments' O.M. No. 19024/1/2006-E.IV dated 24.03.2006, O.M. No. 19024/1/2009-E.IV dated 16.09.2010 and O.M. No. 19024/1/2012-E.IV dated 09.07.2013 regarding guidelines on Air travel. As per these guidelines, in all'cases of Air Travel where the Government of India bears the cost of air passage, Air Tickets may be purchased directly from Airlines (at Booking countersioffice/Website of Airlines) and if needed, by utilizing the services of three Authorized Travel Agents viz. M/s Balmer Laurie & Company Limited (BLCL), M/s Asflok Travels & Tours (ATT) and Indian Railways Catering and Tourism Corporation Ltd. (IRCTC).

- 2. This Department is receiving a large number of proposals from various Ministrice/Departments seeking expost-facto relevation of the prescribed procedure for purchase of air tickets from authorized travel agents only.
- 3. The matter has been reconsidered in this Department. All Ministries/Departments are again directed to:
- (i) Ensure strict compliance of extant guidelines for purchase of air ticket directly from Airlines (at Booking counters/office/Website of Airlines) or from three authorized Travel Agents viz. Mis Beinner Lawrie & Company Limited, Mis Ashok Travels & Tours and IRCTC only by all officials/offices under their control. Hericalorith relaxation on account of Ignorance/unawareness of these guidelines will not be considered by this Department.
- ii) In case of non-availability of authorized agent at a particular place, ticket may be booked from website of Africes or web portal of Balmer Lewrie & Company Ltd., Wis Ashok Travels & Tours and IRCTC.
- iii) In respect of Non-officials of Committees/Boards/Panals, the concerned Ministry/Department have to mentilion in the meeting notice that the Non-official Member has to purchase the ticket from authorized travel agent only otherwise his claim will not be settled by that Ministry/Department.
- iv) All Ministries/Departments of the Government of India, etc. have to widely circulate this O.M. in all offices including attached/subordinate offices/ autonomous bodies under their control with specific instructions to Heads of Departments concerned for strict compilance of these guidelines. Mon-compilance of these guidelines by Ministries/Departments will be treated as lapse on the part of the concerned Ministry/Department.

In accordance with the instructions contained in the Ministry of Finance, Department of Expenditure's O.M. Nos. 19024/1/2009-E-IV, dated 13.07.2009, 16.09.2010 & 28.07,2011 on the subject, as communicated by Ministry of Civil Aviation, certain guidelines (alongwith the proforma seeking relaxation, as issued by MoF) were circulated vide Board's letter of even number dated 16.05.2016 regarding grant of permission to travel by airlines other than Air India for official air travel (both domestic and international) by railway officers. The guidelines, with the advice to furnish some additional particulars were reiterated and re-circulated for strict compilance vide Board's letters of even number dated 17.10.2016 & 22.08.2017. Further, MoF's guidelines contained in their O.M. No. 19024/22/2017-E.IV, dt. 19.07.2017 regarding procedure of purchase of air tickets from authorized travel agents etc. were also circulated on Indian Railways vide Board's letter of even number dated 21.09.2017.

- 2. However, it has been observed in some of the cases that;
- (i) the requests seeking relaxation/permission to travel by airlines other than Air India are not being sent in the prescribed proforms circulated by Ministry of Finance and are not accompanied by requisite documents like approved tour program and undertaking.
- (ii) the proforma for exemption to travel by flight other than Air India is not signed by the officer travelling, and is in some instances signed by Protocol Officer etc.
- (iii) the requests seeking reimbursement of air journey performed in special circumstances are being received without complete particulars and requisite documents like approved tour program and undertaking etc. Also, in some cases the air tickets for which reimbursement is sought have been purchased from travel agents other than the travel agents authorized under MoF guidelines.
- (iv) the above mentioned guidelines are not being observed by the Authority while approving the tour program and while referring cases to Board for approval.
- 3. It is therefore advised that:
- the requests seeking relaxation/permission/reimbursement of air journey should be sent to Board in the prescribed proforma, duly signed by the officer travelling & HOD etc, with all requisite documents like approved tour program and undertaking, as prescribed.
- (ii) the Authority approving the tour programme which includes journey by private airlines should ensure that guidelines of Ministry of Finance circulated vide Board's above referred letters are invariably being followed & complied with.

- (iii) while referring cases to Board for sanction for reimbursement of air tickets, it may be ensured that the tickets have been purchased from authorized travel agents only as per MoF's instructions.

M/s Balmer Lawrie & Company Limited, M/s Ashok Travels & Tours and IRCTC only.

Further, Ministry of Finance (Department of Expenditure) vide their letter No. 19024/22/2017-E.IV dated 27.02.2018 has decided that all such cases of air travel where tickets have been purchased after issue of MoF's O.M. dated 19.07.2017, seeking relaxation of air travel guidelines pertaining to purchase of air ticket from authorized agent, should have the approval of Secretary of the Administrative Ministry before referring the same to Department of Expenditure.

The matter has been re-considered and it has been decided that all such cases of air travel where tickets have been purchased after issue of this Department's O.M. dated 19.07.2017, seeking relaxation of air travel guidelines pertaining to purchase of air ticket from authorized agent, should have the approval of Secretary of the Administrative Ministry before referring the same to Department of Expenditure.
