Govt. of India , Cabinet Secretary has issued order vide letter No. 8/17/2019-EAI-1774 dated 27.08.2019 for monetary allowance of Rs.6000/- per month attached to Asadharan Suraksha Seva Praman Patra (ASSPP). The allowance is payable to defence personnel on deputation to SFF and is payable for life time. Payment of this allowance to retired Indian Army awardees or to spouse of such awardees, posthumously may be made along with pension. Gol, MoD letter No. 8/17/2019-EAI-1774 dated 26.11.2019 has issued order that the 'recipient of all awards, since inception, shall be extended benefits of these awards with effect from the date of issuance of order dated 27.08.2019, in case an officer receive one category of award more than once, the related benefits shall be extended only for one time to him/her.'

- 2. HQrs office letter No. 5619/AT-P/PC/2006/2020 dated 15.07.2021 has directed for making provision of this awards in the system and to notify award to the beneficiary pensioners.

Cabinet Secretariat has clarified that since SFF personnel and Indian Army personnel both draw their salary from Defence Estimates, therefore ASSPP awardees of Indian Army who are either on deputation to Cabinet Secretariat (SFF) or after they have gone back from deputation may continue to draw monetary allowance of Rs. 6000/- per month attached with ASSPP awardees or to spouse of such awardees, posthumously, may be made alongwith their pension.
- 3. As regard framing of modalities for making such payment, the same please be done at your end in consultation with Pension Payment Authority.


