2. The Vidyalaya is to be made functional from the Academic Session 2021-22 onward. For the effective management of the Vidyalaya, it has been decided to designate District Magistrate/Deputy Commissioner/Collector of the concerned district as the Chairman of the Vidyalaya Management Committee.

3. The establishment of the aforesaid Jawahar Navodaya Vidyalaya is subject to following conditions: -

a) The permanent site allotted for the construction of JNV complex will have to be made functional from the point of view of its utilization with provision of roads, access to the premises, supply of water, electricity, telephone connection etc. at the cost of the State Govt.

b) All minor repairs like white-washing, water connections, electricity connections for the buildings offered as temporary accommodation, should be immediately attended to by the District Authorities. Toilets/Bathrooms, normally one each for every 10 students should also be got constructed, if not already constructed.


4 The land allotted for construction of Vidyalaya buildings shall be free from all encumbrances and rights and NVS will have no liabilities in this regard in future.

5 If any of the conditions mentioned above and in the Inspection Report are not fulfilled, it will be open for the Samiti to re-consider the proposal and keep in abeyance the functioning of JNV in Hapur (U.P.).
