**REVISION OF GUIDELINES REGARDING SIMPLIFICATION  
OF REFERRAL SYSTEMS UNDER ECHS: ONLINE APPROVAL OF APPX 'A'**

1. PI ref the following (copies att):-
  - (a) CO ECHS letter No B/49778/AG/ECHS/PA/Ruling dated 28 Jun 2011.
  - (b) CO ECHS letter No B/49774/AG/ECHS/Referral/2020 dt 20 May 2020.
2. It has been observed that for unlisted procedure / investigation, hospitals are sending back the ECHS beneficiaries (Including those of 75 years and above) for getting the approval which is in contravention to Para 26 (g) of SOP on Treatment Management dt 28 Sep 2018/ (available on our website echs.gov.in).
3. It is reiterated that for ECHS beneficiaries, if it is an emergency any investigation / procedure whether listed or unlisted has to be carried out by the hospital without any approval. However, in non emergency condition if the investigation / procedure is listed, no implant / approval will be required and it will be carried out by the hospital but if the investigation / procedure / is unlisted the procedure to be followed is given below :-
  - (a) The empanelled Health Care Organizations (HCOs) will generate Appx A on BPA portal by clicking the icon for Appx A and filling up the card number. The revised format is att as **Appx 'A'**. The basic info will be autofilled through the software. Further details and digital signature of the Doctor will be filled by the empanelled hospital. Thereafter submit button will be clicked.
  - (b) All 136 Nodal ECHS PCs to utilise the existing manpower for getting approval on Appx A from AFMS hospital. The ECHS cells located in BH, AH (R & R) and all Command Hospitals will also be suitably employed for this purpose. Mapping of each nodal PC has been done to the emp hosp and service hosp. The list is attached as **Appendix 'B'**.
  - (c) BPA portal will send 'Pending Appx 'A' popup alert to concerned nodal ECHS PC and the PC will fill up Part-II and put DSC of OIC PC. Thereafter he will take a print out of Appx 'A' and obtain the approval of competent auth i.e. SEMO (upto 2 Lakhs) / CI or Gd Spl of concerned specialty (between 2 to 4 Lakhs) / Sr Adv or Consultant of Concerned Specialty (More than 4 Lakhs).

(d) The revised **Appx 'A'** will be scanned and uploaded by the PC with digital signatures of OIC PC in the relevant claim ID of the concerned hospital. The ECHS beneficiary is requested to kindly contact the concerned empanelled hospital to confirm uploading of **Appx A**. A period of up to 48 hours/two working days may be given for the process.

(e) On getting a confirmation from OIC PC, the ECHS beneficiary will visit the hosp for getting the required investigation / procedure done. The work flow is att as **Appx 'C'** to this letter.

4. If the required specialist officer is not available in the dependent AFMS Hosp of nodal PC, OIC PC will forward the Appx 'A' to the Nodal ECHS PC of Zonal or Command AFMS Hosp, where the concerned specialist officer is available by selecting such Nodal ECHS PC from drop down menu. Pop up alert of 'Pending Appx 'A' will also appear on the screen of receiving Nodal PC. All steps enumerated at Para -3(c), 3(d) & 3(e) to be followed by next nodal PC OIC.

5. **Responsibilities.** The responsibilities of various stake holders is as enumerated below.

(a) **Empanelled HCOs.**

(i) Provisions mentioned at Para 3 to be followed.

(ii) If some unlisted procedure / investigation / implant is required, the hosp will open the BPA portal and click on the Appx 'A'.

(iii) After entering the ECHS Card No, other details of ECHS beneficiary will be auto filled.

(iv) Column 6 to 12 will be filled by treating doctor. Signature and stamp of treating doctor, name qualification and appointment will be ensured on Part-I before submission.

(v) Once Part-I is complete, emp hosp will click the submit button.

(b) **Concerned Nodal PC.**

(i) Once the emp hosp submits Appx 'A' to concerned nodal PC, a pop up alert will appear on the BPA portal of nodal PC.

(ii) PC will fill up the Part-II of Appx 'A' on the portal, put the digital signature of OIC PC and take a print out.

(iii) OIC PC will ensure that all Appx 'A' received on the previous day till 0900 hrs next day are printed out after filling Part-II and are sent to OIC Stats by 0930 hrs to get it approved by 1400 hrs the same day.

(iv) Once Part-III and IV are filled and duly approved Appx 'A' is received back at PC. Thereafter the OIC PC will scan and upload it on the BPA portal by clicking ' Upload Appx 'A' in the concerned Claim ID.

(v) ECHS beneficiary is requested to kindly contact the concerned empanelled hospital after 48 hrs / two working days of raising the Appx 'A' by the hospital.

(c) **Service Hosp.**

(i) On receipt of hard copy of Appx 'A' from ECHS PC, the OIC Stats will segregate them as per speciality and send it to the concerned Specialist / Sr Adv / Consultant as per CFA powers.

(ii) The concerned Specialist / Sr Adv / Consultant will fill up column 15 to 18 of Part-III after checking the details of the case, at the first available opportunity and send it back to OIC Stats at the earliest.

(iii) OIC Stats will compile duly filled Part-III of Appx 'A' and send the file to SEMO for signatures and stamp.

(iv) SEMO will complete Part-IV of Appx'A', put signatures and stamp, at the first available opportunity and sent it back to OIC Stats.

(v) OIC Stats will hand over the complete set of docu to pers from nodal PC by 1400 hrs on each working day.

(d) **UTI-ITSL.**

(i) They will modify the software as explained above within 03 days from the issue of this letter.

(ii) The Workflow is attached as **Appx 'C'**.

(iii) The User Manual is attached as **Appx 'D'**.

6. The revised procedure will be followed by all empanelled HCOs wef 13 Dec 2021 onwards.

7. All RC Directors are requested to disseminate it to all concerned and give a wide publicity for info of all ECHS beneficiaries (Incl aged 75 years and above).

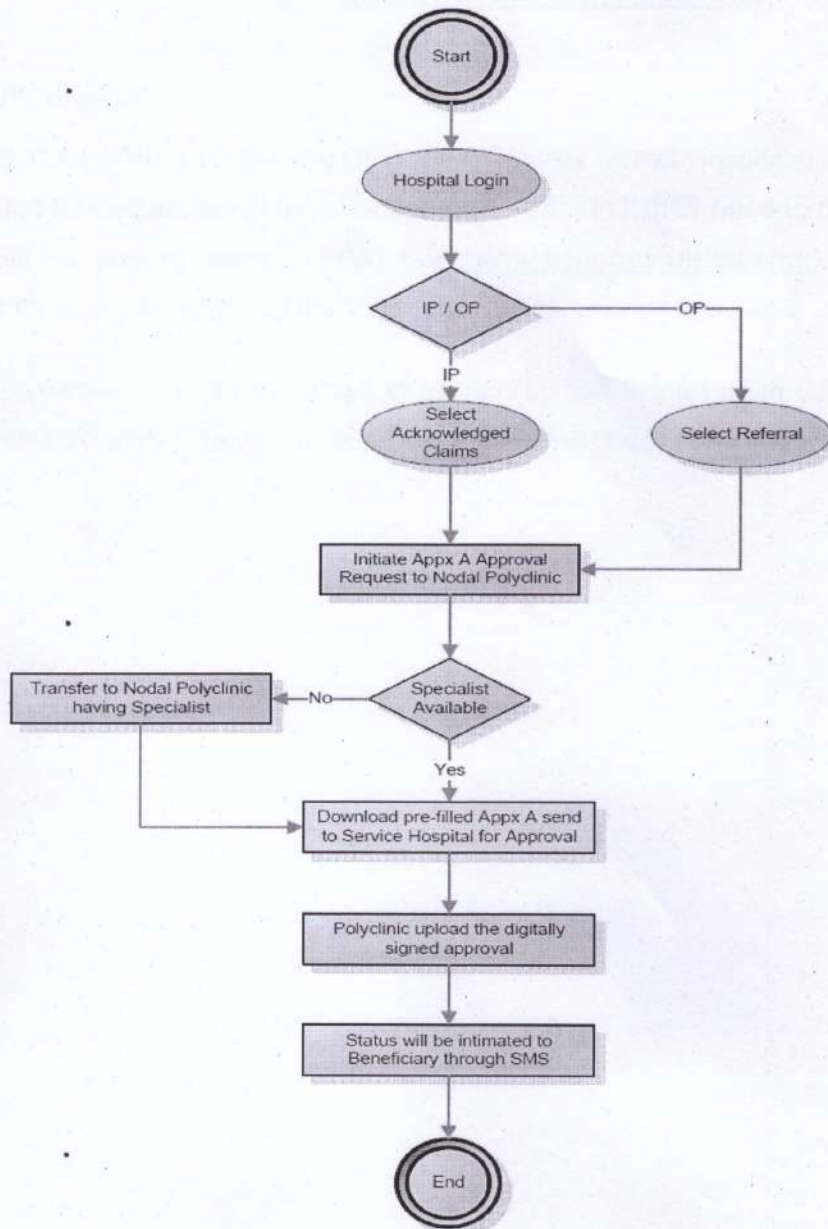

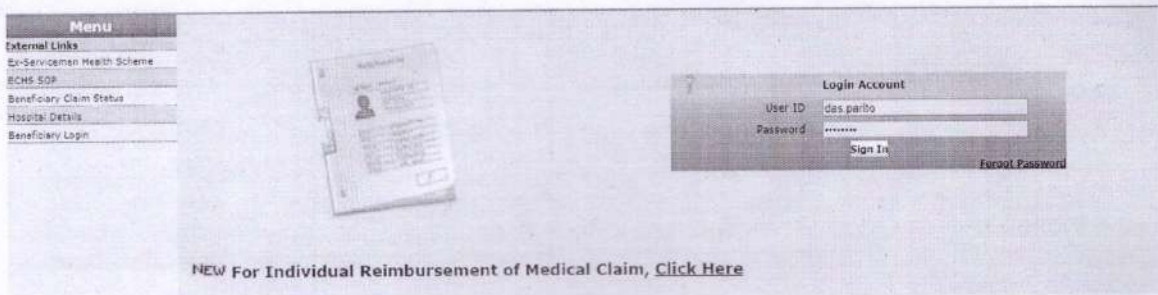

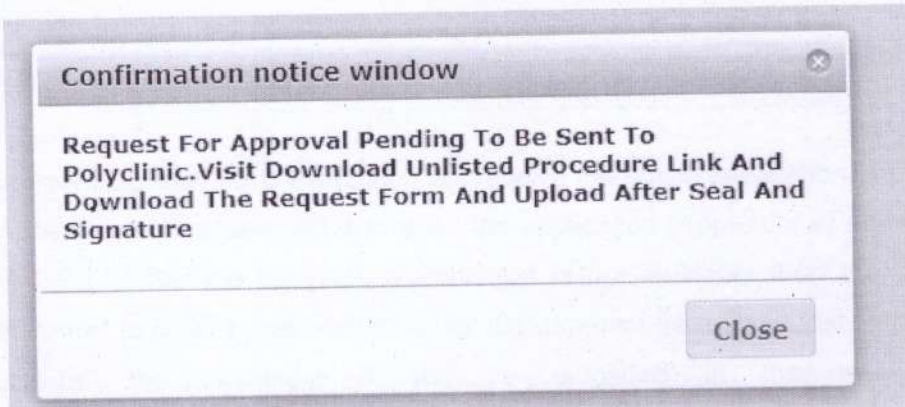

## PRIOR APPROVAL : UNLISTED PROCEDURES/TESTS/IMPLANTS

### Background

3. The prior approval procedure of ECHS as elaborated in our letter under reference at Para 1 was reviewed in light of experience gained thus far and recommendations on the subject received in response to our ibid letter at Para 2. After due deliberation revised procedure has been formulated and the same is enumerated in succeeding paragraphs.

### Prior Approval

4. Prior approval will be required only for those procedures, implants and tests (diagnostic) which are not listed in CGHS rate list of procedures/investigations/ceiling rates of implants. Prior approval for all such cases will be obtained by fastest means of communication to include fax and e-mail from ECHS Polyclinic. Approving authorities for prior approvals are as follows :-

	<u>Cost of procedure/test/implant</u>	<u>Approving Authority</u>
(a)	Less than two lakhs	SEMO/SMO/PMO/CMO
(b)	Two to four lakhs	Service Specialist in concerned speciality
(c)	Above four lakhs	Concerned Senior Advisor/Consultant at Zonal/Comd Hosp [(for NCR- BHDC/ AH (R&R)]

### Channel for Seeking Prior Approval

5. The onus of obtaining prior approval is on the empanelled hospital. It has been experienced that the hospitals have not lived upto expectations in this regard and have forced/coerced patients/their kin to run around with the prior approval documents from hospital to approving authorities. This shall not be accepted henceforth. The hospitals violating this procedure will invite disciplinary action for disempanelment/blacklisting. The documents will be sent by courier/ post/fax/e-mail and not by hand.
6. All prior approvals will be initiated by the Empanelled Hospital where the ECHS patient is undergoing treatment. It will be initiated on the proforma attached as Appx 'A' to this letter, before the proposed procedure/test is carried out. It is mandatory that the treating Specialist/Consultant attaches a detailed case summary justifying the proposed procedure/test/implant with the Appx A.
7. The channel of seeking prior approval is represented diagrammatically at Appx B.
8. The Empanelled Hospital initiating the Appx A will adopt the fastest means to forward the same to the concerned Polyclinic. The OIC Polyclinic will forward the documents to SEMO without delay. SEMO will dispose off all cases upto Rs two lakhs. Cases upto four lakhs will be forwarded to nearest service specialist and those beyond four lakhs will be forwarded directly to Senior Advisor/Consultant.
9. The approving authority after endorsing remarks/approval will forward the proforma back to the SEMO
10. If the SEMO/approving authority feels that the situation is emergent, he/she can communicate his/her opinion directly to the concerned Empanelled Hospital by fax/telephone. This has to be followed by sending the original ink signed hard copy to the concerned Polyclinic.

### Emergency Conditions

11. In certain emergency situations due to the urgency of the case or to save life or limb of a patient, prior approval may not be possible. In all such cases the proposed treatment should continue. **Emergent/life saving treatment will not be denied on the plea that 'Prior Approval' needs to be obtained.** However, the concerned Empanelled Hospital will, in discharge summary, give a detailed justification of the cause as to why the prior approval was not obtained for that particular procedure/test. There is no provision, however, of an ex post facto 'Prior Approval' and the Proforma (Appx A) will NOT be used in such cases.

### Disposal

12. The ink signed copy of prior approval, duly approved by the competent authority, will be attached in original along with the bills being submitted by the Empanelled Hospital for payment.

**Conclusion**

13. With the simplification of prior approval procedure it is expected that patients and their relatives will not be put to avoidable hardships. Stn HQ are requested to ensure that the aforesaid instructions are communicated to all the Empanelled Hospitals/Nursing Homes/Diagnostic Centres in their AOR and that the Proforma for prior approval as per Appx A to this letter is made available in sufficient quantity to them.

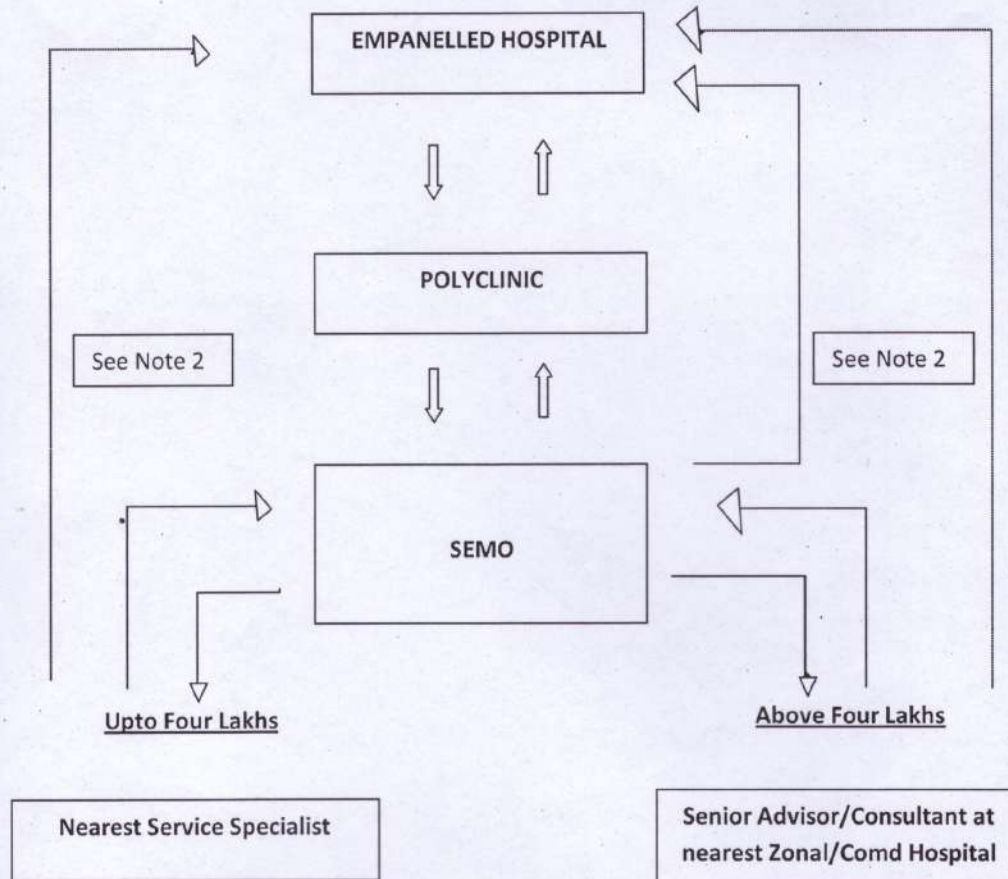

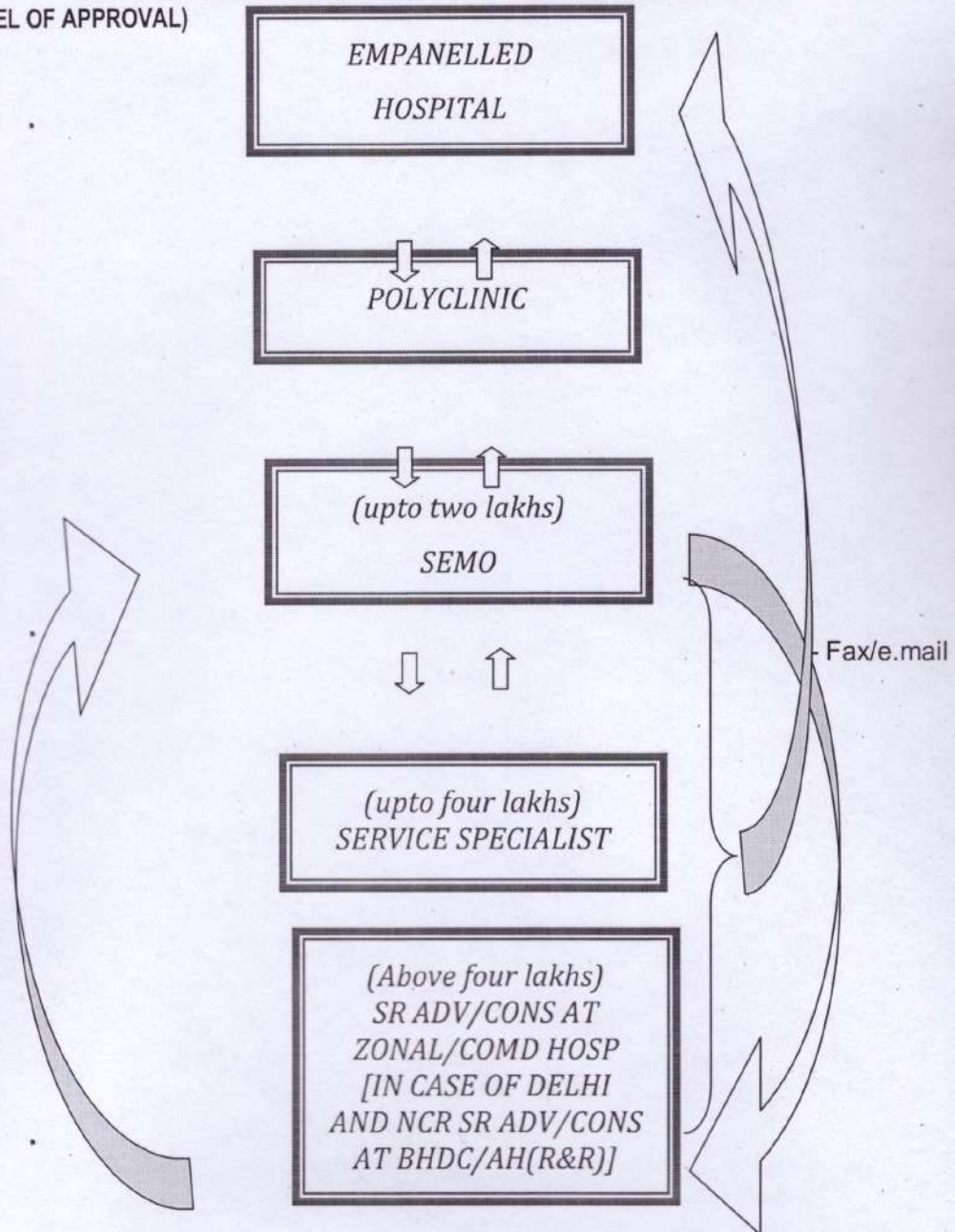

REVISION OF GUIDELINES REGARDING SIMPLIFICATION  
OF REFERRAL SYSTEMS UNDER ECHS

1. Pl ref GoI MoD (DoESW) letter No 22D (06)/2019/(WE)/D(Res) dated 03 Feb 2020 (copy att).
2. GoI has simplified the referral systems under ECHS beneficiaries vide their letter as quoted in Para 1 above. The provisions now applicable for ECHS beneficiaries are as under:
  - (a) Referral from ECHS Medical Officer/ECHS Specialist for consultation with Specialist at Private Hospitals Empanelled under ECHS shall be valid for 30 days in the same hospital.
  - (b) Referral shall be valid for consultation upto 03 times in the same Hospital within 30 days.
  - (c) Referral shall be valid for consultation with a maximum of 03 different Specialist, if required during a single visit.
  - (d) Advice of ECHS Medical Officer/ Specialist for listed investigations shall be valid for a period of 30 days.
  - (e) Advice of ECHS Medical Officer/Specialist for listed treatment procedure shall be valid for a period of 03 months.
  - (f) If any listed investigation advised by Specialist of Empanelled Hospital is required urgently as a medical emergency and certified as such, may be undertaken at the same Hospital.

3. ECHS beneficiaries aged 75 years and above shall be permitted to seek direct OPD Consultation from Specialists of Private Hospitals Empanelled under ECHS without referral from ECHS Polyclinic. However, medicines prescribed will be collected only from Polyclinic. If any investigations/ procedures are advised and are required in emergency, no other authorization is required and the same may be undertaken. However, in non-emergency conditions approval of competent authority is required if any non-listed investigations/ procedures are advised. Medicines prescribed will be collected only from Polyclinics.

4. Critically ill ECHS beneficiaries shall be permitted for follow up treatment in ECHS Empanelled Hospitals as per the details given under:-

(a) Permission/Referral for post-operative follow-up treatment in respect of following post-operative conditions requiring frequent Consultations from Specialist at Private Hospitals Empanelled under ECHS need not be re validated from time to time on each occasion of the follow up treatment which may be undertaken at CGHS rates without time limit. However it is advised to patients to revalidate the referral from PC once in six months.

(b) The consultation/ investigation are permitted under these follow-up cases. The conditions covered are:-

- (i) Post Cardiac Surgery Cases including Coronary Angioplasty.
- (ii) Post Organ transplant Cases (Liver, Kidney, Heart etc)
- (iii) Post Neuro Surgery Cases/ Post brain Stroke cases requiring regular follow-up treatment.
- (iv) End Stage Renal Disease/ follow up cases of Liver Failure.
- (v) Cancer treatment.
- (vi) Auto-immune disorder like Rheumatoid Arthritis requiring regular follow-up.
- (vii) Neurological disorder like Dementia, Alzheimer's disease, parkinsonism etc.

(c) Medicines prescribed may be provided by ECHS Polyclinic.

(d) However, if any non-listed investigation/ procedure are advised, during the follow up permission/ referral from competent authority shall be required except in emergency.

5. The action to be taken by various agencies are enumerated in the succeeding paragraphs:-

(a) Action to be taken by Polyclinics/Regional Centres

- (i) Referral shall be valid for consultation upto 03 times in the same Hospital within 30 days. Validity of claim ID once used during the first visit needs to be extended for the next two visits also. Necessary changes in the UTI website will be carried out by CO ECHS.
- (ii) Referral shall be valid for consultation with a maximum of 03 different Specialists, if required during a single visit. If the specialist at the pvt. Emp Hospital suggests for cross consultation then the same needs to be endorsed in the OPD note.
- (iii) Separate dropdown menu in the BPA portal for uploading the claims by the Emp hospital in r/o veterans above 75 yrs age who have been neither referred nor are emergency cases will be made by BPA.
- (iv) Validity of referral is not exceeding 30 days.
- (v) Not more than three consultations have been taken on one referral.
- (vi) Not more than three specialists have been consulted on one referral with due justification in clinical notes.
- (vii) All pts as per Para 2 above are to be checked.
- (viii) In case of veterans more than 75 yrs of age, the claims will be generated without any referral from the PC only for OPD consultation and emergency procedures. Referral will be required for non-emergency procedures.

(b) Action to be taken by Emp Hosps. - Emp Hosps will ensure the following:-

- (i) All pts mentioned in Para 2 will be implemented in letter and spirit.
- (ii) For Para 2 (f), the info to PC is sent within 48 hours.
- (iii) For Para 3 the claims will be uploaded in the separate dropdown menu of BPA portal for veterans more than 75 years of age who have been neither referred nor are emergency cases.
- (iv) For Para 4 the hosp will advise patients for a review at PC after six months.


(c) Action to be taken by BPA.

(i) SDCPL. It is requested to incorporate the default provisions in referral generation module of software as mentioned vide Para 2 to 5 above, at respective touch points and confirm implementation status within seven days. A workflow in respect of same should also be submitted.

(ii) UTI-TSL. It is requested to incorporate provision mentioned vide Para 2 to 5 above in the claim initiation and referral acceptance procedure of empanelled hospitals in your online module and submit the workflow for same. The BPA teams should also be advised to take a note of these provisions in processing of online bills.

6. This policy shall be effective from date of issue of GoI MoD (DoESW) letter mentioned at para 1 of this letter.
