- The matter has been examined and it has been decided that the new method of identification as approved vide MoD letter of even no. dated 15.06.2020 and extended upto September, 2021 or till the Covid 19 situation improves whichever is earlier vide letter of even no. dated 21.05.2021, shall remain operative up to March, 2022 or till the Covid-19 situation improves, whichever is earlier.
