Of late, references are being received from field Controllers seeking clarification on retention of DAD Pool accommodation by the Officers/staff who have been transferred from Static stations to Non-static stations under GREF.

2. In this regard attention is invited to MoD (Finance Division)'s letter No.AN/XIV/14004/III/Vol.IV(PC), dated 30.03.1994 and No. F.12(3)/C/2003, dated 16.04.2003 (copies enclosed) wherein guidelines were issued regarding retention of accommodation or alternatively, admissibility of HRA applicable to their last duty station in respect of those DAD employees who are transferred from Static to non-static stations, from one non-static to another non-static station. A list of Static stations has also been annexed to MoD letter dated 30.03.1994. Further, it has been stated therein, that all other stations other than Static stations will be called non-static stations.

3. Accordingly, PCDA/CDA/Estate Officers of DAD Pool accommodation are requested to deal with such cases in terms of ibid MoD orders.

SUB :- Grant of House Rent Allowance to the DAD employees attached to GREF.

Sir,

I am directed to refer to your UO note No. AN/XIV/14004/III/Vol. IV (RC) dated 30-9-93 and to convey the sanction of the President for the grant of HRA to DAD employees attached to GREF as per the following conditions/procedures:

- (i) Those DAD employees who are transferred from Static to non-static stations would be allowed either retention of Government accommodation at their last duty station or, alternatively, HRA applicable to their last duty station.
 - (ii) Those who are transferred from one non-static to another non-static station will get HRA at the unclassified city rates.
 - (iii) Other DAD personnel will get HRA as per the terms and conditions applicable to other civilian employees of Central Government.
2. The order with reference to para 1 (ii) above will have retrospective effect from 1.9.93. The orders with reference to para (i) & (ii) above will take effect from the date of issue of these orders.
3. This issues with the concurrence of IFA (DAD).

ADMINISTRATIVE INSTRUCTIONS ON STATIC STATIONS
IN GREF GRANT OF PA TO GPF PERSONNEL

1. Reference Govt. of India (MOPT, BRDB letter No F. B1(1)/87-Estt dated 12 Jul 1993.
2. Static & Non-Static Stations are defined in the succeeding paragraphs.
3. Static Stations. Location of all static units/ installations like HQ DGBR, Hqs CE(P), Base Depots, Base Workshops, Store Divisions, Transit Depots, GREF Centre & Records, LO DGBR and similar static installations will be called static stations. In addition, all States/Union Territory Capitals where GREF units are located and all stations where family accommodation for GREF personnel has been sanctioned will also be called static stations. The list of static stations is given in Annexure I (attached).
4. Non-Static Stations. All other stations other than static stations will be called non-static stations.

Subject: Delegation of Powers to Principal Controllers/
Controllers to sanction retention of accommodation at the last
duty station in case of transfer to NER, Andaman & Nicobar
islands, non-static GREF stations and stations in field areas etc

Sir,

I am directed to refer to CGDA UO No. AN/ XVIII/ 18087/2/ Vol.I dated 22.5.2002, NO.AN/XVIII/ 18087/2/Vol.X dated 9.7.2002 and dated 26.11.2002 on the above subject and to state that the proposal regarding delegation of powers to Principal Controllers/ Controllers to allow retention of DAD accommodation at the last duty station(s) where alternative accommodation could not be allotted to enable such Govt. servant(s), transferred to NER, Andaman & Nicobar Islands, non-static GREF stations and stations in field areas etc. to keep their families behind at the last duty station(s), presently held by CGDA delegated earlier in relaxation of Rule 23 & 25 of the Allotment of Govt. Residences (DAD Pool) Rules, 1986, has been under examination for some time past.

2. The competent authority, now, keeping in view of the difficulties being experienced by the DAD Officers/ Staff consequent on their transfer to J&K, NER, Andaman & Nicobar Islands, Lakshadweep, Non-static GREF stations and stations in field areas etc., has, in exercising Rule 25 of Allotment of Government Residences (DAD Pool) Rules, 1986, delegated the powers presently held by CGDA to Principal Controllers/ Controllers to allow the retention of DAD Pool Accommodation to DAD employees at last duty station(s) on merit in relaxation of Rule 23 thereto. Since the retention in respect of General Pool Accommodation is extended up to 30.6.2005, the approval is restricted up to that extent subject to further extension issued by Directorate of Estates or till such time, fresh Allotment of Government Residences (DAD Pool) Rules, are framed.
