# Para 5. Provision of Medicines & Consumables on Reimbursement Basis to ECHS Beneficiaries if 'NA' with Polyclinic/ Authorised Local Chemists (ALC)

(a) The said provision has been approved by GoI (MoD) vide letter at Para 1 above. Separate provisions exist for 'Special Conditions' and 'General Conditions' which have been covered in succeeding paras.

### (b) 'Special Conditions' for reimbursement of NA Medicines.

- (i) These are as indicated at Para 6 of Appx to MoD letter No 24(8)/03/USD(WE)/D(Res) dt 19 Dec 2003. The special conditions are :-
  - (aa) Post operative cases for major Cardiac Surgery/Interventional Cardiology.
  - (ab) Obcology.
  - (ac) Post operative organ transplant cases.
  - (ad) Post operative joint replacement cases.
  - (ae) Post operative major Neurosurgical/Neurology cases.

- (aa) Non Cancer Drugs.

  - (abb) Financial Limit. Upto Rs 5,00,000.00 ( Rupees Five Lakhs)

- (i) All conditions except those covered at Para 5 (b) (i) above will be treated as 'General Conditions'.
- (i) <u>Provision for reimbursement of Medicines for 'General Conditions' at a Time</u>.
  - (aa) Upto No of Days. 30
  - (ab) Financial Limit. Upto Rs 25,000.00 (Rupees Twenty Five thousand).

### EXECUTIVE INSTRUCTIONS: PROCEDURE RE-IMBURSEMENT OF MEDICINES AND CONSUMABLES TO ECHS BENEFICIARIES

- 1. Reference GoI (MoD) letter No 22D(01)/2016/WE/D(Res-1) dated 30 Jan 19 (copy attached as Encl 1).
- 2. Provision of assured medicine supply to ECHS beneficiaries is critical for ensuring their medical care. While various measures / provisions exist, approval of reimbursement of medicines and consumables by GoI (MoD) vide letter at Para 1 will ensure that ECHS beneficiaries are able to get their medicines timely. These executive instructions are being issued to outline the process which will be further improved based on the environmental feedback.
- 3. Primary Responsibility for Provisioning of Medicines & Consumables by SEMOs/SEDOs.
  - (a) SEMOs are responsible for provision of medicines & consumables wef 10 Oct 16 vide O/o DGAFMS letter No 19189/DGAFMS/DG-2C/ECHS dt 10 Oct 2016.
  - (b) SEDOs are responsible for provision of dental medicines wef 07 Jul 2017 vide O/o DGAFMS letter No 19189/DGAFMS/DG-2C dt 07 Jul 17.
  - (c) SEMOs and SEDOs will continue to remain primary source of centralised medicine supply as these medicines come at most competent rates.
  - (d) Salient aspects of medicine management have been covered in SOP on Medicine Management issued on 05 Sep 17 vide Central Org ECHS letter No B/49762/AG/ECHS/Medicine dt 05 Sep 17.
  - (e) Since calculation of Monthly Maintenance Figure (MMF) was an important input for correct provisioning of medicines, a comprehensive SOP on 'Calculation

of MMF in ECHS Polyclinics' has been issued on 19 Feb 19 vide Central Org ECHS letter No B/49762/AG/ECHS dt 19 Feb 19.

(f) Focus of medicine supply will remain on 'curative segment' as highlighted in SOP on Treatment Management in ECHS issued vide Central Org ECHS letter No B/49770/AG/ECHS/Treatment dt 28 Sep 2018.

# 4. <u>Provision of Medicines & Consumables through Authorised Local Chemist</u> (ALC) if NA with Polyclinics.

- (a) GoI (MoD) has approved provision of ALC vide their letter No 22D(01)/2016/WE/D(Res-I) dated 22 Aug 17 for which executive instrs were issued vide our B/49762/AG/ECHS/Medicine Policy dated 29 Aug 17. This entailed provision of an Authorised Local chemist (empanelled chemist shop) to provide 'NA' medicines immediately if within premises of ECHS Polyclinic and within 24 hr if ALC is located within municipal limits in which concerned ECHS PC was located. Minimum discount from MRP was 15% but the vendor with maximum discount was to be selected based on the laid down procedure.
- (b) Based on the ground challenges, the conditions of empanelling ALC were further relaxed vide Gol (MoD) letter No 22D(01)/2016/WE/D(Res-I) dt 25 Jun 18 wherein medicines could be provided within 72 hr when ALC was located outside municipal limits. Jan Aushadhi Stores were deemed empanelled as additional entity to provide NA medicines. Bank Guarantee & Turnover clauses have also been relaxed substantially.
- (c) Polyclinic wise monetary ceiling for monthly expdr are as under :-

(i) <u>Type A & B</u>. Rs 2.5 Lakhs.

(ii) Type C. Rs 1.5 Lakhs.

(iii) Type D. Rs 1 Lakh.

- (d) The monetary ceiling can be further enhanced by sanction of MD ECHS as per procedure as authorised in our letter No B/49762/AG/ECHS/Medical Policy dt 07 Jan 19. For this, the case has to be initiated by controlling Station HQs.
- (e) Focus of medicines supply will continue to remain on 'curative segment'.

# 5. <u>Provision of Medicines & Consumables on Reimbursement Basis to ECHS</u> <u>Beneficiaries if 'NA' with Polyclinic.</u>

- (a) The said provision has been approved by GoI (MoD) vide letter at Para 1 above. Separate provisions exist for 'Special Conditions' and 'General Conditions' which have been covered in succeeding paras.
- (b) Special Conditions' for Reimbursement of NA Medicines.
  - (i) These are as indicated at Para 6 of Appx to MoD letter No 24(8)/03/US(WE)/D(Res) dt 19 Dec 03. The special conditions are:-

- cases for major Cardiac Surgery/ Post operative Interventional Cardiology
- (ab) Oncology
- Post operative organ transplant cases (ac)
- Post operative joint replacement cases. (ad)
- Post operative major Neurosurgical/ Neurology cases. (ae)

### Provision for Reimbursement for 'Special Conditions' at a Time. (H)

- (aa) Non Cancer Drugs.
  - (aaa) Upto No of Days. 30.
  - Upto Rs 75,000.00 (Rupees (aab) Financial Limit. Seventy Five Thousand)
- Cancer Drugs. (ab)
  - (aba) Upto No of Days. 30.
  - Upto Rs 2,00,000.00 (Rupees Two (abb) Financial Limit. Lakhs).

### 'General Conditions' for Reimbursement of NA Medicines. (C)

- All conditions except those covered at Para 5(b)(i) above will be treated as 'General Conditions'.
- Provision for Reimbursement of Medicines for General (n) Conditions' at a Time.
  - (aa) Upto No of Days. 15.
  - Upto Rs 25,000.00 (Rupees Twenty Five Financial Limit. (ab) Thousand).

### 6 Procedure.

- When an ECHS beneficiary reports to an ECHS Polyclinic for OPD treatment or after discharge from Service/ Govt/ Empanelled Hospital for collection of medicines and consumables, ECHS Polyclinic will provide the medicines and consumables from SEMO/SEDO supplied resource as available in ECHS Polyclinic
- If the medicine is 'NA', attempt will be made to provide the same through ALC and/ or Jan Aushadhi Stores empanelled
- If the medicine is 'NA' from ALC as well, NA certificate will be issued as per enclosed format (Encl 2) by OIC PC. Vitamins and supplements should not be included in 'NA' certificate.

- (d) While issuing the NA certificate, OIC Polyclinic should ensure that the certificate has the names of the medicines in 'generic form'/ salt details preferably. Branded drugs if prescribed should be supported with due medical justification by the prescribing doctor. The OIC PC should ensure that no substitute of the same is available in the generic form before issuing NA certificate for branded drugs.
- (e) Medicine bill has to be in the name of ECHS beneficiary as given in ECHS card of the beneficiary. Any variation will make the claim 'Null & Void'.
- (f) NA should be given for minimum No of days (subject to stipulation as per Para 5 above) by which assured availability of medicines through SEMO/ SEDO/ ALC can be issued to the patient viz if a patient requires medicines for 15 days but availability of needed medicines can be ensured after five days, NA will be given for five days only. It would be the responsibility of the PC to inform the ESM via SMS or telephonically, when the medicines are available in PC, in order to ensure that ECHS beneficiary is not made to run around. A fine balance between financial probity and inconvenience to ECHS beneficiary has to be maintained.
- (g) Bills will be processed as individual reimbursement bill through dependant Polyclinic and paid by concerned Regional Central by funds allotted under Code Head 365/00.
- (h) List of Documents to be submitted to OIC of parent PC for processing of the claim:-
  - Copy of ECHS Card.
  - (ii) Prescription Slip.
  - (iii) NA certificate as per Encl 2.
  - (iv) Bill.
  - (v) Copy of cancelled cheque with bank details.

### (j) Duties of OIC PC.

- (i) OIC PC will verify the following things:-
  - (aa) Individual details to be verified with smart card database.
  - (ab) Medicines in the bill are the same as written in NA certificate.
  - (ac) The No of days for which the medicine is purchased is the same as endorsed in NA certificate. Bills submitted are within laid down limits based on Special/ General Conditions.
  - (ad) Bill should include GST/TIN.
- (ii) Upload the bill though UIT-BPA as individual reimbursement bill.

- 7. This policy will come in force wef 30 Jan 19 from the date of issue of Govt letter at Para 1 above.
- This has approval of MD ECHS.

In continuation of MoD letter of even no. Dated 25-6-2018 the sanction of the Competent Authority in MoD is conveyed for re-imbursement of medicines and consumables in respect of ECHS beneficiaries for maximum period of 15 days at a time subject to maximum value of medicines and consumables not exceeding Rs.25,000/- each time under general conditions and 30 days at a time subject to maximum value of medicines and consumables not exceeding Rs.75,000/- each time except in case of cancer drugs where the maximum value of medicines and consumables would be Rs.2,00,000/- each time under special conditions. This would be further subject to obtaining Non Availability Certificate (NAC) from OIC ECHS, Polyclinic. 

# AMENDMENT TO EXECUTIVE INSTRUCTIONS: PROCEDURE FOR RE-IMBURSEMENT OF MEDICINES AND CONSUMBALES TO ECHS BENEFICIARIES

- Ref Central Org ECHS letter No B/49762/AG/ECHS/Medicine Policy dt 08 Apr 2019.
   Fwg amendments are being done to simplify the reimbursement procedure based on feedback from envt.
- The fwg docu will be required for reimbursement of medicines and consumables:-
  - (a) There will be no requirement of a separate NA certificate. Since the prescription holds all the details, the same will be treated as NA certificate. The prescription will be signed by Pharmacist and countersigned by OIC PC after issuing the available medicines and NA medicines will be indicated on the prescription only.
  - (b) The bill for medicines purchased by the ESM should be in the name of ECHS beneficiary as given in ECHS card.
  - (c) A cancelled cheque/photocopy of the same to be submitted, if the ESM is claiming the bill for the first time. The same is not required subsequently. The onus of ensuring correct bank details will rest with the ESM.
  - Vitamins and supplements (incl adult diapers) to be included in prescription slip ONLY if they
    are prescribed for some ailment/disease as primary treatment.
  - 4. The veterans are allowed to submit a consolidated bill for the complete duration of NA (each NA will however not exceed 15/30 days as specified under gen/special condition).
  - Balance documents such as copy of ECHS card, NA certificate with signature of three officers, individual contingent bill, revenue stamp and file cover etc will be done away with.

### Procedure for processing NA Med claim by OIC PC:-

- (a) OIC PC to prepare a consolidated Contingent Bill once every fortnight & fwd it to RC after digitally signing the same (by OIC & OIC ECHS Cell) via email or submitting on hard copy.
- (b) Hard copies of bills of all claims mentioned in the contingent bill to be submitted to the RC by the 30<sup>th</sup> of every month to enable processing for audit.
- (c) Format of Contingent Bill (PC wise) is att as per appx to this letter
- These amendments shall come to effect forthwith and pending bills will also be governed by this procedure. This has the approval of MD, CO ECHS.
