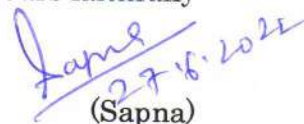

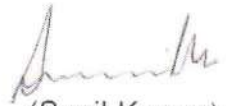
OFFICE MEMORANDUM
