- Empanelement of CGHS empanelled hospital is subject to this hospital providing proof of its being a CGHS empanelled facility as on the date signing of MoA with ECHS.
- CGHS empanelled medical facilities will be empanelled with ECHS for the period for which
  the facilities hold valid CGHS. The MoA will be extendable onece CGHS renew the MoA with the
  medical facilities.

NABH accredited medical facilities will be empanelled with ECHS for the period of validity of NABH certificate and the MoA will be renewed once the medical facility is issued revalidation/renewed NABH certificate.
