A meeting was held by CGDA HQrs Office with NSDL representative to streamline delays involved in generation of PRAN.

During the meeting, NSDL representative has demonstrated online generation of PRAN through e-NPS portal. Through this portal an employee can apply online for generation of PRAN using email id and PAO can validate details of employee online leading to generation of PRAN without any delay. In this connection, NSDL representative has provided two PPTs; one for employee on how to initiate application through e-NPS and another for PAO on online validation of PRAN. Copies of both presentations are enclosed.

Therefore, following links can be used for Registration of subscriber/ employee on e-NPS for generation of PRAN and online validation by PAO.
