Sub:- Provision of domestic PNG connections in residential units belonging to Railways.

Ref:- Northern Railway's letter No. 196-W/3313/Land dated 20.12.2022.

Railway Board had permitted NR & WR proposal for laying of PNG pipeline to Indraprastha Gas Limited (IGL) and Mahanagar Gas Limited (MGL) respectively in railway colonies for the use of residence of railway employees.

Now, a reference has been received from Northern Railway seeking clarifications on the examination of a similar proposal received from gas agencies other than IGL.

In this regard it is informed that the proposals for providing domestic PNG connections in residential colonies by the agencies approved by Petroleum and Natural Gas Regulatory Authority, Ministry of Petroleum and Natural Gas may be considered on merit. Being a welfare measure, no way leave charges for laying PNG gas pipelines in railway colonies for providing PNG facilities to railway beneficiaries are to be levied. Further, the model adopted by WR with the approval of Railway Board (copy enclosed) may be adopted by all zonal railways and Production units for dealing with such cases with the concurrence of FA&CAO and approval of General Manager.

Sub.: Provision of domestic PNG connections in residential units belonging to

Western Railway in Mumbai.

Ref.: Western Railway's letter No. W/PNG/Officers Flat (W4) dated 22.12.2015.

Western Railway vide their letter cited above have forwarded a proposal in regard to PNG connection facilities to Western Railway colonies across Mumbai by Mahanagar Gas Limited (MGL). The proposal has been examined in Board's office. The main features of the same are as under:

(a) Interest free refundable security @ Rs. 5000 per flat, totalling to Rs. 12.70 lakhs for providing PNG connections to 254 railway quarters, is to be deposited with MGL in Phase-I. The connections will be provided only to the railway employees and it will not be provided to outhouses.

(b) Wherever excess length of pipe/tube, (than the standard length prescribed by MGL) is required, the cost of the excess length along with the labour charges will also have to be borne by Railways, on non refundable basis, over and above the refundable security.

(c) An advance of Rs. 1250/- for consumption of gas is to be deposited by the allottees per connection, which is refundable at the time of disconnection.

The proposal of MGL has been considered and it has been decided to permit laying/provision of PNG connections to Railway quarters/colonies of Western Railway in Mumbai on similar lines as has been done in other Government colonies/Railway colonies in Delhi. Expenditure under this shall be chargeable to Revenue and funds shall be found from within the existing budget allotment.

This issues with concurrence of Finance Directorate of Ministry of Railways.
