## **OFFICE MEMORANDUM**

Sub:- De-empanelment of Major Ranbir Singh Memorial Hospital Divyajyoti Specialities, Ganga Nagar, Meerut from CGHS Meerut empanelled list-reg.

On surprise checking/ inspection conducted by the undersigned alongwith Addl.DDG (HQ), CGHS and AD (HQ), CGHS New Delhi, it is found that **Major Ranbir Singh Memorial Hospital Divyajyoti Specialities** was violating the terms & conditions of MoA (serious lapes in patient care and record maintenance) with CGHS.

In this connection a show cause notice was served vide this office letter of even no. dated 04.09.2025 and the explanation received from the Major Ranbir Singh Memorial Hospital Divyajyoti Specialities was found unstatisfactory and hence it has been decided to de-emapanel the hospital from CGHS Meerut w.e.f. 16.09.2025 and impose penalty by way of encashment of 15 % of performance bank Gurantee. Rest of Performance Bank Guarantee of Hospital will be released subjected to deduction of penalties and adjustment /recovery of any outstanding dues (if any) after three months or settlement of all the bill, which will be later, from the date of de-empanelment of the hospital as per the rules/MoA.

Further, Major Ranbir Singh Memorial Hospital Divyajyoti Specialities is given the following insturctions.

- 1. Hospital shall not be allowed to provide treatment to CGHS beneficiaries w.e.f. 16.09.2025.
- 2. Provide treatment to already admitted CGHS beneficiaries till they become stable and get discharged. Their bills are to be submitted to National Health Authority/concerned department, as the case may be, with justification for consideration and payment.
