OFFICE MEMORANDUM

Subject: - De-empanelment of Family Hospital and Research Center Kanpur from CGHS, Kanpur empaneled list.

As per OM No. C-31018/35/2024-Vig dated 21.07.2025, Nirman Bhawan, New Delhi under directions of **Central Vigilance Commission** and **Vigilance** Division MoHFW a committee was formed for comprehensive audit of medical bills of hospitals under CGHS, Kanpur.

The committee also inquired into complaint received regarding uploading of false and fraudulent bills on NHA Portal by Family Hospital and Research Center Kanpur and on the recommendation of the committee, it has been established that Family Hospital and Research Center Kanpur **violated** the Memorandum of Agreement with CGHS, Kanpur by uploading fraudulent and fabricated bills in r/o two beneficiaries on three separate occasions.

In this connection, it has been decided by the undersigned, as per recommendation of the committee and in consultation with higher authorities, to De-empanel Family Hospital and Research Center Kanpur from CGHS, Kanpur w.e.f 25.09.2025, 12.00 o'clock midnight.

Further, Family Hospital and Research Center Kanpur is given the following instructions.

1. A Penalty equivalent to 15% of the security deposit is being imposed on Family Hospital and Research Center Kanpur.
2. Recovery of amount of Rs. 44696/- paid to the hospital against fraudulent bills will have to be deposited as a draft by Family Hospital and Research Center Kanpur in favor of AD, CGHS, Kanpur.
3. Family Hospital and Research Center Kanpur shall not be allowed to provide diagnostic, OPD, IPD etc. treatment to CGHS beneficiaries and the hospital is not allowed to admit new CGHS patients from 25.09.2025, 12.00 o'clock midnight.
4. Family Hospital and Research Center Kanpur are directed to provide treatment to already admitted CGHS beneficiaries till they become stable and get discharged. Their
