
Subject: Revision of rates of Dearness Allowance to the employees, who are continuing to draw their pay in the pay scale as per 5th Central Pay Commission.

The undersigned is directed to refer to this Department's O.M. No. 1/4(iii)/2025-E.II(B) dated 6th October, 2025 on the subject mentioned above and to say that the rate of Dearness Allowance (DA) in respect of employees, who are continuing to draw their pay in the pre-revised pay scale as per 5th Central Pay Commission, shall be enhanced from the existing rate of 474% to 483% of Basic Pay w.e.f. 1st January, 2026.

2. The provisions contained in paras 3, 4 and 5 of this Ministry's O.M.No.1(13)/97-E.II(B) dated 3rd October, 1997 shall continue to be applicable while regulating Dearness Allowance under these orders.

No. 1/4(ii)/2025-E.II(B) dated 6th October, 2025 on the subject mentioned above and to say that the rate of Dearness Allowance (DA) in respect of employees, who are continuing to draw their pay in the pre-revised pay scale/Grade Pay as per 6th Central Pay Commission, shall be enhanced from the existing rate of **257% to 262%** of Basic Pay w.e.f. **01st January, 2026**.

2. The provisions contained in paras 3, 4 and 5 of this Ministry's O.M.No.1(3)/2008-E.II(B) dated 29th August, 2008 shall continue to be applicable while regulating Dearness Allowance under these orders.
